Breakaway Camp - RISK Management Process

Why do Risk Management at Breakaway Camp?

The Breakaway Camp Leadership Team is committed to providing a safe environment through effective risk management. This means that all your behaviours and activities will involve informed decisions based on a reasonable analysis of foreseeable risks.

Implementing sound risk management practices is a continuous journey. Risk Management utilises a systematic process to manage (identify, analyse, assess, monitor, control and report / communicate) risks. The risk management process is a dynamic and ongoing process, not a one-off exercise.

Safety will be achieved through identifying and analysing risks, assigning risk owners and the implementation of pro-active risk reduction, prevention and continuous monitoring strategies.

How do we do Risk Management at Breakaway Camp?

1) Identify Risks

Objective: *Identify risks that pose an impact, either positive or negative, on a part of camp and require some form of management. Effectively, we should identify what, why, and how things can arise as the basis for further analysis*

Key questions to be asked include: -

- What is the risk - generate list.
- Why is it a risk - confirmation question?
- How and why it can happen (what is the source of the risk, under what situation can it occur).

These are a wide range of methods that enable us to identify risks for the camp. Some methods include: -

- Brainstorming alone or with other people.
- Personal experiences.
- Past history of incidents / losses.
- Gut feel / judgement.
- Etc.

Tools: *Use the Breakaway Camp Risk MATRIX to identify and rate risks & assign owners to the risk*

For each activity, we should complete a Risk MATRIX entry to determine the initial risk. If the initial risk is considered unacceptable, then we complete the Risk PLAN

2) Analyse the Risks

Objective: To assess the risks in terms of Likelihood and Severity and assign an owner to each risk.

Key questions to be asked include: -

- What is the likelihood of the risk occurring?
- If it does occur, what is the magnitude of impact?
- Who is the appropriate person to manage the risk?
- What are the strategies / mitigation controls currently in place?
- How effective are these strategies / mitigation controls?

To help in the Analysis, try this: -

Likelihood	Description
Almost Certain	Could happen Frequently
Likely	Could happen Often
Possible	Could happen Occasionally
Unlikely	Could happen but Rare

Severity	Description
Catastrophic	Death or Permanent Disability
Severe	Serious Bodily Injury
Moderate	Requires Medical Treatment
Minor	First Aid Only

3) Develop Strategies & Plans and Implement Them

Objective: To identify possible mitigation strategies to reduce, eliminate, transfer, or accept the consequence and / or the likelihood of the risk.

- Identify all mitigation strategies that can be used to reduce its rating to an acceptable level.
- For each risk mitigation strategy: -
 - 1) Identify the actions needed to implement it.
 - 2) Who will be responsible for each action?
- After the mitigation strategy has been actually been implemented, reassess the severity and likelihood of the risk to ascertain the new level of risk. The risk management process is a dynamic and ongoing process, not a one-off exercise. We must monitor the activity to ensure the risk remains acceptable.
